An inadequate response, intolerance, or contraindication to Enbrel AND Humira or a clinical rationale for use of the requested agent instead of Enbrel AND Humira; OR 2. Chronic Lymphocytic Leukemia (CLL); OR 3. Diffuse Large B-cell Lymphoma (DLBCL) ; OR
