- Probuphine® (buprenorphine implant)

The Plan may authorize coverage of the above products for members meeting the following criteria:

<b>Required Medical Information</b>	<b>buprenorphine-naloxone SL tablets</b> 1. A diagnosis of opioid dependence; AND 2. Intolerance to the sublingual film formulation of Suboxone® that is not expected to occur with

the requested medication; AND

3. For doses greater than 24 mg to 32 mg per day, both of the following:
  - a. An inadequate response to 24 mg of buprenorphine daily and that there is a high risk for relapse; AND
  - b. A dose taper was tried and failed in the previous 3 months or was not attempted due to a high risk of relapse

**Bunavail® (buprenorphine-naloxone buccal films)**

1. A diagnosis of opioid dependence; AND
2. Intolerance to the sublingual film formulation of Suboxone® that is not expected to occur with the requested medication; AND
3. For doses greater than 12.6 mg per day, both of the following:
  - c. An inadequate response to 12.6 mg of buprenorphine daily and that there is a high risk for relapse; AND
  - d. A dose taper was tried and failed in the previous 3 months or was not attempted due to a high risk of relapse

**Zubsolv® (buprenorphine-naloxone SL tablets)**

1. A diagnosis of opioid dependence; AND
2. Intolerance to the sublingual film formulation of Suboxone® that is not expected to occur with the requested medication; AND
3. For doses greater than 17.2 mg per day, both of the following:
  - e. An inadequate response to 17.2 mg of buprenorphine daily and that there is a high risk for relapse; AND
  - f. A dose taper was tried and failed in the previous 3 months or was not attempted due to a high risk of relapse

**buprenorphine SL tablets**

1. A diagnosis of opioid dependence; AND
2. One of the following:
  - a. An adverse reaction or contraindication to naloxone; OR
  - b. Attestation that the member is pregnant; OR
  - c. Both of the following:
    - i. The member is currently breastfeeding; and
    - ii. The member is stable and the prescriber assesses the patient to be at minimal risk of abusing buprenorphine or other drugs of abuse
3. For doses greater than 24 mg to 32 mg per day, both of the following:
  - a. An inadequate response to 24 mg of buprenorphine daily and that there is a high risk for relapse; AND
  - b. A dose taper was tried and failed in the previous 3 months or was not attempted due to a high risk of relapse

**Belbuca®(buprenorphine buccal film)**

**buprenorphine transdermal patch 5mcg, 7.5 mcg, 10mcg, 15mcg and 20mcg (generic for Butrans®)**

	<ol style="list-style-type: none"> <li>1. Diagnosis of moderate to severe chronic pain; AND</li> <li>2. An intolerance to a trial of morphine extended release tablet (MS Contin); AND</li> <li>3. An inadequate response to at least a 2-week trial of, intolerance or contraindication to a non-narcotic agent at the maximum tolerated dose; OR</li> <li>4. Attestation that prescriber wants to avoid using a full opioid agonist</li> </ol> <p><b>Probuphine (buprenorphine implant)</b></p> <ol style="list-style-type: none"> <li>1. A diagnosis of opioid dependence; AND</li> <li>2. Member has achieved and sustained prolonged clinical stability on transmucosal buprenorphine product; AND</li> <li>3. Member is on 8mg or less per day for 3 months or longer without any need for supplemental dosing or adjustments; AND</li> <li>4. Inability to continue to take oral buprenorphine products due to clinical condition; AND</li> <li>5. There is no plan to use supplemental sublingual buprenorphine treatment after implant insertion; AND</li> <li>6. There is no expectation to have treatment with Probuphine for over 12 month's total.</li> </ol>
<b>Age Restriction</b>	Belbuca, buprenorphine transdermal patch: 18 years or older
<b>Prescriber Restriction</b>	None

<b>Other criteria</b>	<p><b>Probuphine Reauthorization:</b></p> <ol style="list-style-type: none"> <li>1. A diagnosis of opioid dependence; AND</li> <li>2. Member has achieved and sustained clinical stability with implant without treatment-related adverse events; AND</li> <li>3. Member has not been receiving supplemental sublingual buprenorphine since implant insertion; AND</li> <li>4. Member has no shown no signs of opioid dependence relapse; AND</li> <li>5. Implant insertion will not be at same site that was previously used for injection and there was no prior implants inserted in the contralateral arm.</li> </ol>
