Required Medical Information	<ol style="list-style-type: none"> 1. Diagnosis of Cushing’s disease; AND 2. Pituitary surgery is not an option OR pituitary surgery has not been curative; AND 3. Baseline 24-hour urine free cortisol level is ≥ 1.5 times the upper limit of normal; AND
